POSITION SUMMARY

This is a temporary technician position for shellfish flupsy operation at Clam Fresh Enterprises. The Technician occupying this position is responsible for assisting with recording data, cleaning, sorting and care taking of manila clam and pacific oyster seed. Employee will assist with land based nursery operations when needed and must be available during weekends.

ESSENTIAL DUTIES

1. Care taking of manila clam and pacific oyster seed.
2. Meeting company expectation in terms of quality control.
3. Maintain and Report inventory numbers.
4. Record and Report the import and export of seed in the flupsy.
5. Sorting of shellfish by size and species.
6. Maintaining cleanliness of flupsy silo's and flupsy structure.
7. Understanding daily goals through communication through flupsy lead.
8. Assisting with tracking survival rate of manila clam and pacific oyster seed.
9. Assisting with land-based nursery operations when needed.
10. Assisting with green house when needed.

PHYSICAL REQUIREMENTS
